Purpose

The Parties hereby agree to collaborate and cooperate in the following areas:

- 1. Conducting training programs on small-scale industries, honey production, and bakery skills for the rural population in and around Anuppur, Madhya Pradesh.
- 2. Sharing knowledge, resources, and expertise to enhance the quality and effectiveness of the training programs.

Terms and Conditions:

Duration:

This MOU shall be effective from the date of signing and shall remain in force for a period of 5 Years.

Responsibilities:

a. GCJ agrees to:

- i. Design and deliver training modules on small-scale industries, honey production, and bakery skills.
- ii. Provide qualified trainers and necessary teaching materials for the training programs.
- iii. Make appropriate arrangements for the training venue, equipment, and facilities required for the programs.

b. DISS agrees to:

- Assist in identifying the target beneficiaries from the rural communities.
- ii. Coordinate with GCJ to schedule the training programs and ensure the participation of the selected beneficiaries.
- iii. Provide logistical support, such as arranging transportation and accommodation for the participants, if required.

Funding:

The Parties agree to explore and secure funding opportunities jointly or individually for the successful implementation of the training programs. The specific funding arrangements will be agreed upon through separate agreements or grants.

Reporting and Evaluation: The Parties shall maintain regular communication to exchange progress reports, share feedback, and discuss any necessary adjustments to the training programs. Evaluation of the programs' effectiveness and impact shall be conducted jointly by the Parties.

Intellectual Property: Any intellectual property created jointly or individually by the Parties during the course of this collaboration shall be shared and utilized in a mutually agreed-upon manner.

Confidentiality:

The Parties shall treat any confidential information shared during the course of this collaboration with utmost confidentiality and shall not disclose it to any third party without prior written consent.

Termination

This MOU may be terminated by either Party upon providing a written notice of [Number of days] to the other Party. Termination shall not relieve the Parties of any obligations accrued prior to the effective date of termination.

Governing Law and Dispute Resolution:

This MOU shall be governed by and construed in accordance with the laws of the [Applicable Jurisdiction]. Any disputes arising out of or in connection with this MOU shall be resolved amicably through mutual negotiations. In case of failure to reach a resolution, the disputes shall be referred to arbitration in accordance with the
