WHEREAS,

Govt. College Jaithari, Anuppur (M.P.) (hereinafter referred to as "College") is an educational institution that aims to promote environmental awareness and sustainable practices.

The Department of Forest, Block Jaithari, Dist- Anuppur (M.P.) (hereinafter referred to as "Forest Department") is responsible for the

conservation and management of forests and natural resources in the region.

The Parties recognize the importance of collaboration to enhance environmental protection, promote afforestation, and share resources for mutual benefits.

NOW, THEREFORE, the Parties agree as follows:

Objective:

The objective of this MOU is to establish a framework for cooperation and collaboration between the College and the Forest Department to promote afforestation, resource sharing, and environmental awareness.

Scope of Cooperation:

- a) The College agrees to actively participate in afforestation activities initiated by the Forest Department in and around the College premises.
- b) The Forest Department agrees to provide technical guidance, plant saplings, and necessary resources to the College for plantation drives.
- c) The Parties will jointly organize awareness campaigns, workshops, and seminars to educate students and the community about the importance of environmental conservation.

Responsibilities of the College:

- a) The College shall designate a responsible faculty member to liaise with the Forest Department and coordinate plantation activities.
- b) The College shall ensure the availability of suitable land for plantation drives within the College premises.
- c) The College will actively involve students in the plantation and maintenance activities.

Responsibilities of the Forest Department:

- a) The Forest Department shall provide expert advice, technical support, and necessary resources for successful plantation activities.
- b) The Forest Department will supply saplings and necessary equipment for the plantation drives.
- c) The Forest Department will monitor and assess the progress of plantation activities and provide necessary feedback to the College.

Resource Sharing:

- a) The Forest Department agrees to share research findings, reports, and publications related to afforestation and environmental conservation with the College.
- b) The College agrees to provide the Forest Department with access to its library resources and academic materials related to environmental studies.

Duration:

This MOU shall be effective from the date first mentioned above and shall remain in force for a period of three (3) years. It may be extended or amended by mutual consent of the Parties in writing.

Termination:

Either Party may terminate this MOU by providing written notice to the other Party at least thirty (30) days prior to the intended termination date. Termination shall not affect any ongoing activities, and the Parties shall cooperate in completing any pending obligations.

Governing Law and Dispute Resolution:

This MOU shall be governed by and construed in accordance with the laws of the Republic of India. Any disputes arising out of or
