### Purpose:

The purpose of this MOU is to establish a partnership between the College and Nagar Parishad to conduct training sessions and awareness programs for the students of the College. ### Scope of Collaboration:

## The College agrees to:

- a. Nominate a team of faculty members to organize and conduct the training sessions in collaboration with Nagar Parishad representatives.
- **b.** Provide necessary support, resources, and facilities for the successful implementation of the training programs.
- c. Encourage and motivate students to actively participate in the cleanliness and awareness activities organized by Nagar Parishad.

- **b.** Organize awareness programs, workshops, and practical sessions related to cleanliness, waste segregation, and proper disposal of waste.
- c. Facilitate the participation of Nagar Parishad officials, experts, and volunteers in the training programs.

#### Duration:

This MOU shall come into effect on the date of signing and shall remain valid for a period of 05 Years. The Parties may extend this MOU by mutual consent in writing.

- c. Providing feedback and suggestions for improvement to Nagar Parishad, if necessary.

#### Nagar Parishad shall be responsible for:

- a. Developing training modules and materials related to cleanliness and awareness.
- **b.** Coordinating with the College to finalize the dates and logistics of the training programs.
- c. Ensuring the availability of necessary resources and materials for the training sessions.

#### Confidentiality:

Any information shared between the Parties during the course of collaboration shall be treated as confidential and shall not be disclosed to any third party without prior written consent.

#### Amendments:

Any amendments or modifications to this MOU shall be made in writing and signed by both Parties.

#### Termination:

Either Party may terminate this MOU by providing a written notice of termination to the other Party. The termination shall be effective [number of days, e.g., 30 days] from the date of receipt of the notice.

#### Governing Law:

This MOU shall be governed by and construed in accordance with the laws of State.
